WHEREAS, the affected property owner has requested the vacation of the sewer easement in Lot 2, Block 46 of City Heights, Map No. 1007; the general utility easement in Parcel 1 of Parcel Map No. 15205; and the sewer and water easement in the vacated unnamed alley, Block 46 of City Heights, Map No. 1007 and Lot 1, Map No. 6740, to un-encumber this property; and

WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the easements either for the purpose for which they were originally acquired, or for any other public use of a like nature that can be anticipated; and;
 - (b) the public will benefit from the vacation through improved utilization of land, and
- (c) the vacation is not inconsistent with the General Plan or an approved Community

 Plan or Redevelopment; and
- (d) the purpose for which the easements were originally acquired will not be detrimentally affected by these vacations; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the sewer easement more particularly described in legal description "A1" and as shown on Drawing No. 20304-B attached hereto as Exhibit "B1"; the general utility easement more particularly described in legal description "A2" and as shown on Drawing No. 20305-B attached hereto as Exhibit "B2"; and the sewer and water easement more particularly described in legal description "A3" and as shown on Drawing Nos. 20306-1-B and 20306-2-B attached hereto as Exhibit "B3" are ordered vacated.
- 2. That the City Clerk shall then cause a certified copy of this resolution, with the legal descriptions "A1," "A2," and "A3" and Exhibits "B1," "B2," and "B3," attested by him under seal, to be recorded in the Office of the County Recorder.
