A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO RATIFYING THE ELECTION RESULTS OF MAY 18, 2005 FOR THE BARRIO LOGAN REDEVELOPMENT PROJECT AREA COMMITTEE.

WHEREAS, on October 30, 1989, the Council of the City of San Diego (Council) by Resolution No. R-274651 adopted the Procedure of the Formation of a Project Area Committee (PAC) for the Barrio Logan Redevelopment Project (Project); and

WHEREAS, on December 8, 2003 the Council by Resolution No. R-298704 amended the Procedure for Formation of a PAC for the Barrio Logan Redevelopment Area; and

WHEREAS, on April 19, 2005 the Council by Resolution No. R-300360 authorized a one-year extension of the PAC and directed Redevelopment Agency staff to notice and conduct an election for the Barrio Logan Redevelopment Area PAC in 2005; and

WHEREAS, the annual election was conducted on May 18, 2005, after notice and according to the Project PAC by-laws and procedures enumerated within the documents approved by the Council; and

WHEREAS, a representative from the City Clerk's office attended the May 18, 2005 election to ensure its validity; and

WHEREAS, the elected members of the Project Area Committee have submitted information establishing the qualifications of each person relative to district, category or organization as appropriate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Barrio Logan Redevelopment Project Area Committee consisting of persons named on the list of Project Area Committee members receiving the highest number of votes attached hereto as Exhibit A and incorporated herein by this reference is hereby approved as constituting a representative Project Area Committee.
2. That the Council hereby concurs that the election results of May 18, 2005 are valid and binding in accordance with the procedures so adopted by Resolution Nos. R-298704 and R-300360.
