A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF FISCAL YEAR 2006 OPERATING AGREEMENTS FOR THE EXISTING BUSINESS IMPROVEMENT DISTRICTS.
