A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE DETACHMENT OF DESIGNATED PARCELS LOCATED WITHIN THE SCRIPPS-MIRAMAR RANCH MAINTENANCE ASSESSMENT DISTRICT.

WHEREAS, the Scripps-Miramar Ranch Maintenance Assessment District [the District] was established in August, 1969, and re-engineered in Fiscal Year 1998 for compliance with Article XIIIID of the California Constitution; and

WHEREAS, an assessment engineer has determined that certain property does not receive special benefit from the maintenance of the improvements in the District; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council hereby authorizes the detachment of certain property [Detached Property] from the existing District pursuant to California Streets and Highways Code sections 22605 and 22609.
