

RESOLUTION NUMBER R- 300827

ADOPTED ON SEP 19 2005

WHEREAS, Dale Naegle, Fellow of the American Institute of Architects, having established Naegle Architects in La Jolla Shores in 1954, has been a proponent of the shopkeeper concept and was recently honored by the San Diego Historical Resources Board for the architectural significance of the Mills Residence, a prime example of the Modernist movement and a representative example of Mr. Naegle's early work, generously donated his services in designing the Kellogg Park Outdoor Shower and Public Restroom as a reflection of Fred Liebhardt's style, sensitive to the importance of blending it in with its surroundings; and

WHEREAS, Louis Beacham, owner of Beacham Construction and well respected local Contractor, member of the Board of Trustees of the La Jolla Community Planning Association, and longtime community volunteer, accepted the onerous challenge of building the much needed Comfort Station, for no profit; and

WHEREAS, Donald Goertz, a member of the American Institute of Architects and Construction Specifications Institute, having hung out his shingle as a private Architect in La Jolla Shores twenty-seven years ago, graciously donated his time and effort, providing structural and mechanical expertise, taking the project through the Permit process, and providing all the architectural change orders, thus ensuring the San Diego community first class accommodations at Kellogg Park; and

WHEREAS, Sean O'Neill, Landscape Designer and owner of Scenic View Landscaping, noted for his unique, artistic designs for residential landscapes and urban condominium patios, having gotten his start through invaluable experience gained as a volunteer at Balboa Park and its nursery, has generously donated his design talents, resulting in a beautiful garden for all to enjoy; and

WHEREAS, Mary Coakley, a dedicated community volunteer, member of the City of San Diego Committee for Standardization of Park Comfort Stations, and newly appointed member of the Board of Directors for the American Restroom Association, following extensive research, designed the floor plan to provide a safe and accessible facility with maximum function in minimum space affording ease of maintenance and successfully coordinated acquisition of donations from businesses and individuals who helped make the Comfort Station a tasteful addition to La Jolla Shores; and


