Auditor and Comptroller is hereby authorized to appropriate and expend \$865,500 from CIP No.59-002.0, Sidewalks Replacement and Reconstruction, Fund No. 104402, Street Division Capital Improvement fund, for the purpose of funding a construction contract and related expenses, contingent upon the Auditor and Comptroller first certifying that funds are or will be on deposit with the City Treasurer.
- 4. That the plans and specifications for Replacement of Tree Root Damaged Sidewalks Fiscal Year 2006 Citywide, Group C-31 as advertised by the Contract Administrator for bids is hereby approved.

- 5. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder in an amount not to exceed \$777,000, contingent upon the Auditor and Comptroller first certifying that funds are or will be on deposit with the City Treasurer.
- 6. That the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer any excess funds to the appropriate reserves.
- 7. That the replacement or reconstruction of damaged sidewalks is categorically exempt from the California Environmental Quality Act pursuant to Guidelines section 15301 as the maintenance or repair of existing facilities.
