WHEREAS, the City Manager was previously authorized by the Council of the City of San Diego by Resolution R-299624, adopted September 13, 2004, to award a contract to Telliard Construction for the construction of ancillary improvements to the Point Loma Community Park Ballfield (the Project); and,

WHEREAS, Project construction was to proceed in two phases, with Phase I comprising the construction of a retaining wall, landscaping, and an irrigation system; and with Phase II comprising the construction of a seating/viewing terrace; and,

WHEREAS, unforeseen and unanticipated conditions have subsequently increased the estimated construction costs for Phase I of the Project; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the transfer of an amount not to exceed \$20,000 from C.I.P. No. 29-495.0, La

  Jolla Cove Comfort Station Improvements to C.I.P. No. 29-844.1, Point Loma Community Park

  Ballfield Viewing Terrace Phase I, Fund No. 102232, Transient Occupancy Tax-Coastal

  Infrastructure is hereby authorized.
- 2. That the City Auditor and Comptroller is authorized to appropriate and expend an amount not to exceed \$20,000 from C.I.P. No. 29-844-1, Point Loma Community Park Ballfield Viewing Terrace Phase I, Fund No. 102232, Transient Occupancy Tax-Coastal Infrastructure, for the purpose of providing additional funds for the construction of the Project.

- 3. That the Council of the City of San Diego finds that this activity is not a project for purposes of the California Environmental Quality Act pursuant to CEQA Guidelines Section 15378(c) because it constitutes a subsequent discretionary approval of the Project as previously approved by Council.
- 4. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.
