WHEREAS, the Municipal Code also provides that the membership of the Commission shall consist of seven members appointed by the Mayor and eight additional members, one each from a list of up to three nominations submitted by each Councilmember; and

WHEREAS, there will be four vacancies on the Human Relations Commission due to the expired terms of Joyce Singer Abrams, Michael J. Pérez, Robert L. Blumberg, and Grover Diemert, each of which expired on July 22, 2005; and

WHEREAS, the office of Mayor is currently vacant; and

WHEREAS, San Diego City Charter section 25 requires that the Deputy Mayor perform all the duties of the Mayor as prescribed by the Charter or by ordinance in the absence of the Mayor; NOW, THEREFORE,
