WHEREAS, Lyric Opera San Diego has completed this project while faced with the challenge of funding such a major undertaking in the current economic climate, and it is a reflection of the depth of commitment of Lyric Opera's supporters and donors and the faith the community places in the organization that this dream has been brought to life; and

WHEREAS, with the North Park Theater restoration, Lyric Opera will be able to fulfill

the vision of its directors, Leon Natker and J. Sherwood Montgomery, to become San Diego's

English-language opera company, establish itself as a leading regional opera company, and fill a

niche in San Diego no other performing arts organization does; and

WHEREAS, the North Park Theatre restoration represents a major step in the

revitalization of the North Park area, as well as an affordable, modern venue for a variety of

other performing arts organizations, schools, and more; and

WHEREAS, the STEPHEN AND MARY BIRCH NORTH PARK THEATRE will be

officially dedicated in an on-stage ceremony on Friday, September 30, 2005; NOW,

the grand reopening of the newly restored STEPHEN AND MARY BIRCH NORTH PARK
