San Diego Comic Opera, and now as Lyric Opera San Diego; and

renovated Stephen and Mary Birch North Park Theatre, having raised funds for the rebirth of the

theater, creating a state-of-the-art performing arts venue out of an architectural gem, and

anchoring the redevelopment of one of San Diego's finest historic neighborhoods; and

WHEREAS, with the opening night performance of Gilbert and Sullivan's wonderful

classic "The Mikado," on October 14, LYRIC OPERA SAN DIEGO embarked on an exciting
