WHEREAS, city employee David Cowan [Cowan] was acquitted of all charges against him in the action entitled *U.S. v. Cowan*, *et, al.* United States District Court Case No. 03CR2434-JM; and

WHEREAS, Cowan incurred legal expenses now due to his attorney, Michael L. Crowley, in the amount of \$136,028.84, for his defense;

NOW THEREFORE, BE IT RESOLVED by the Council of the City of San Diego that:

- 1. Based on the verdict in the action entitled *U.S. v. Cowan, et, al.* United States District Court Case No. 03CR2434-JM, city employee David Cowan's attorney, Michael L. Crowley, be paid in the amount of \$136,028.84 for the cost of his defense.
- 2. The Auditor and Comptroller furnish a certificate in the amount of \$136,028.84 to Michael L. Crowley setting aside such funds.
