## RESOLUTION NUMBER R- 301049 ADOPTED ON NOV 2 1 2005

A RESOLUTION OF THE CITY OF SAN DIEGO APPROVING PLANS AND SPECIFICATIONS FOR AS-NEEDED DRILLING SERVICES FOR ENVIRONMENTAL SITE INVESTIGATIONS; AUTHORIZING A CONTRACT WITH THE LOWEST BIDDER; AUTHORIZING THE EXPENDITURE OF FUNDS FOR SUCH SERVICES; AND AUTHORIZING THE RETURN OF EXCESS BUDGETED FUNDS.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the plans and specifications for as-needed drilling services in connection with environmental site investigations for the Environmental Services Department, filed in the office of the City Clerk as Document No. <u>W.o.</u> 050445, are approved.
- 2. That the Contract Processing and Awards section of the City is authorized and directed to proceed to publish, in accordance with law, a notice to contractors calling for bids for the work described in paragraph 1 above, in accordance with the plans and specifications referred to in that paragraph.
- 3. That, after advertising for bids in accordance with the law, the City Manager is authorized to award a contract to, and execute a contract with, the lowest responsible and reliable bidder, for as-needed drilling services, in an amount not to exceed \$155,000.
- 4. That the expenditure of an amount not to exceed \$155,000 solely and exclusively for the above contract is authorized, to be expended as follows: \$75,000 from Fund No. 30244, CIP 33-084.0, Underground Hazardous Materials Storage Tanks; \$25,000 from Fund No. 100, Fire Department; \$40,000 from Fund No. 100, Police Department; and \$15,000 from Fund No. 100, Park & Recreation Canyon Side Stables.

- 5. That the City Auditor and Comptroller is authorized to return excess budgeted funds, if any, to the contributing funds upon advice of the administering department.
- 6. That this activity is categorically exempt from CEQA pursuant to CEQA guideline section 15306, because the agreement is for the purposes of information collection and other resource evaluation activities which do not result in a serious or major disturbance to an environmental resource.
