BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to expend an amount not to exceed \$30,000 from CIP No. 52-715.0, Woodman Street Sidewalk Eastside, Fund 30244/30300, TransNet, for the purpose of constructing minor street

improvements, contingent upon the City Auditor and Comptroller first furnishing one or more certificates demonstrating that funds are available.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves on advice of the administering department.

BE IT FURTHER RESOLVED, that this activity is exempt from CEQA pursuant to State CEQA Guidelines sections 15060(b)(3) and 15378 because it is a governmental fiscal activity that is not committed to a specific project which may have a significant impact on the environment.
