AN ORDINANCE AUTHORIZING EXECUTION OF A FIRST AMENDMENT TO CONSULTANT AGREEMENT WITH RICHARD BRADY & ASSOCIATES FOR THE MORENA, BARRETT, AND LOWER OTAY DAM OUTLET TOWER IMPROVEMENTS PROJECT.

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 2. That this activity is categorically exempt from the California Environmental Quality Act [CEQA] pursuant to CEQA Guidelines section 15302 as this activity is the replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced.
