A RESOLUTION DECLARING THE RESULTS OF THE
SPECIAL RUN-OFF ELECTION HELD IN COUNCIL
DISTRICT 2 AND IN COUNCIL DISTRICT 8 IN THE
CITY OF SAN DIEGO ON JANUARY 10, 2006

WHEREAS, a special run-off election was held in Council District 2 and in Council District 8 in the City of San Diego on Tuesday, January 10, 2006, pursuant to the provisions of Ordinance No O-19416 (New Series), adopted September 26, 2005, for the purpose of electing a candidate to the office of Councilmember in District 2 and for the purpose of electing a candidate to the office of Councilmember in District 8; and

WHEREAS, a copy of the certificate of the Registrar of Voters of San Diego County canvassing the returns of the special run-off election, as certified to the City Clerk, has been duly received; and

WHEREAS, a canvass of these elections has been completed and the City Clerk has certified the results to the City Council; and

WHEREAS, declaring the results of the election as certified by the Registrar of Voters and the City Clerk is a ministerial act required by California Elections Code section 10263 and, therefore, is not subject to veto by the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council finds and determines, pursuant to the provisions of Section 27 0411 of the San Diego Municipal Code, as follows.

I

The whole number of votes cast in Council District 2 was 29,448, and the whole number of votes cast in Council District 8 was 9,090.

II

The total vote received by each candidate at the special run-off municipal election is as follows:


