A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ADOPTING TEMPORARY RULE 2 2 REGARDING THE ORDER OF BUSINESS OF COUNCIL MEETINGS

WHEREAS, Rule 9 of the Permanent Rules of Council provides that the Rules

Committee may, at any time, place on the Adoption Agenda a resolution establishing a

temporary rule that shall supersede a permanent rule for the time period as may be specified in
the temporary rule; and

WHEREAS, the Rules Committee has considered the adoption of a temporary rule to replace and supercede Permanent Rule 2.2 regarding the order of business for Council meetings; and

WHEREAS, the temporary rule would move Special Orders of Business from Mondays to Tuesdays, consolidate Consent Items on Monday under the Adoption Agenda to Tuesdays, permit Noticed Hearings and Special Hearings to be docketed on Mondays when needed, place Public Comment on Closed Session items after the Adoption Agenda on Monday, and note that Closed Session items are heard on Tuesdays at 9:00 a.m.; and

WHEREAS, under Charter section 280(a)(1) this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following temporary rule, to be known as "San Diego City Council Temporary Rule 2 2" is hereby adopted:
