BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to appropriate and expend an amount not to exceed \$128,030.20 from C.I.P. No 21-855 5, Balboa Park Veterans Memorial Garden, Fund No. 38217, 2002 Resources Park Bond Per Capita grant funds, to fund construction and related costs for the Balboa Park Veterans Memorial Garden [the Project]

BE IT FURTHER RESOLVED, that the Council of the City of San Diego finds that this activity is adequately addressed in the environmental document and there is no change in circumstance, additional information, or project changes to warrant additional environmental review Because the prior environmental documents adequately covered this activity as part of

the previously approved project, the activity is not a separate project for purposes of CEQA review per CEQA Guidelines Section §15060(c)(3) and 15378(c).
