A RESOLUTION OF THE CITY OF SAN DIEGO AUTHORIZING A FIVE-YEAR AGREEMENT WITH LUTH & TURLEY, INC. FOR AS-NEEDED REMEDIATION AND CLEANUP SERVICES; AUTHORIZING EXPENDITURES; AND FINDING NO ENVIRONMENTAL IMPACT.

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized to execute, for and on behalf of the City, an agreement for five years with Luth & Turley, Inc., to perform remediation and cleanup services, on an as-needed basis, including reconstruction of properties damaged by water main breaks, sewer backups, and other insurance related services, under the terms and conditions set forth in the Agreement, on file in the office of the City Clerk as Document No. RR-

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$2,000,000 per year is authorized for such services, contingent on City Council approval of each department's operating budget in each fiscal year, and provided that the City Auditor first furnishes one or more certificates demonstrating that the funds necessary for the above expenditure are, or will be, on deposit in the City Treasury.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves upon advice from the administering department.

BE IT FURTHER RESOLVED, that this activity is categorically exempt from the California Environmental Quality Act pursuant to CEQA Guidelines section 15301, as the repair and maintenance of existing facilities.
