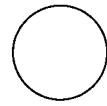

DATE OF FINAL PASSAGE MAR 01 2006

A RESOLUTION OF THE CITY OF SAN DIEGO APPROVING PLANS AND SPECIFICATIONS FOR THE SEWER PIPELINE REHABILITATION PROJECT, PHASE C-1; ESTABLISHING PHASE FUNDING FOR THE PROJECT; AWARDING THE CONTRACT; AUTHORIZING THE EXPENDITURE OF FUNDS; REQUIRING PREVAILING WAGES; AND FINDING NO ENVIRONMENTAL IMPACT.

WHEREAS, in order for the City to meet the requirement to reduce sewer spills imposed by the U.S. Environmental Protection Agency, the City has been rehabilitating pipelines and will now proceed with the third phase of such rehabilitation; and

WHEREAS, the City Council has the discretion to require, on a case by case basis, based on the evidence in the record, that prevailing wages be paid on its public works municipal affair projects when the Council determines that doing so will provide an economic benefit to the City, and

WHEREAS, Council Resolution No R-298185 directs that advertising for bids include a prevailing wage specification on all City public works "municipal affair" water and/or sewer fund projects when the engineer's estimate for the construction of the project exceeds ten million dollars, and

WHEREAS, the Pipeline Rehabilitation Project, Phase C-1, is a public works "municipal affair" sewer fund project falling within the parameters of the resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1 That the plans and specifications for the construction of the Pipeline Rehabilitation Phase C-1 Project, including the prevailing wage specification, filed in the office of the City Clerk as Document No. W.O. 179294, are hereby approved.

2. That, after advertising for bids in accordance with the law, the Mayor or his duly authorized designee is hereby authorized to establish contract funding phases and to award the contract to the lowest responsible and reliable bidder in an amount not to exceed \$12,561,745, provided that the City Auditor and Comptroller first furnishes one or more certificates demonstrating that the funds necessary for this expenditure under established contract funding phases are, or will be, on deposit with the City Treasurer.

3. That the expenditure of an amount not to exceed \$12,561,745 is hereby authorized for the above project, to be expended as follows: \$12,011,186 from Sewer Fund No. 41506, CIP 46-050.0, Annual Allocation – Pipeline Rehabilitation, for project construction and related costs, and \$550,559 from Sewer Fund No. 41506, CIP 46-193.0, Annual Allocation – Muni Pooled Contingency, for project contingency; provided that the City Auditor and Comptroller first furnishes one or more certificates demonstrating that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.


4. That the City Auditor and Comptroller is further authorized to transfer excess budgeted funds, if any, from this project to the appropriate reserves on advice of the administering department.

5. That the Mayor is further authorized to include state prevailing wage requirements in the contract awarded for this project

6 That this activity is categorically exempt from the California Environmental Quality Act pursuant to CEQA Guidelines sections 15301 and 15302, as repair and reconstruction of existing sewer structures and facilities.
