
BE IT RESOLVED, by the Council of the City of San Diego, that the Sixth Amendment to the City of San Diego's Nondisposal Facility Element, adopted on July 25, 1994 in Resolution No. R-284332, is hereby adopted as set forth in the Sixth Amendment, on file in the office of the City Clerk as Document No. RR- 301268.

BE IT FURTHER RESOLVED, that in accordance with the California Public Resources Code, the Mayor or his designee is hereby authorized and directed to submit the above Sixth Amendment to the California Integrated Waste Management Board.

BE IT FURTHER RESOLVED, that this activity is statutorily exempt from the California Environmental Quality Act [CEQA] pursuant to CEQA Guidelines section 15282(p)

because it constitutes the amendment of a nondisposal facility element as set forth in Section 41735 of the Public Resources Code.


