A RESOLUTION OF THE CITY OF SAN DIEGO AUTHORIZING THE EXPENDITURE OF STORM WATER POLLUTION PREVENTION FUNDS AND CONVENTION CENTER EXPANSION FUNDS FOR EXISTING PROFESSIONAL SERVICES AGREEMENTS WITH THE METROPOLITAN WASTEWATER DEPARTMENT; AND FINDING NO ENVIRONMENTAL IMPACT BY THIS FISCAL ACTION.

WHEREAS, the Storm Water Pollution Prevention Division [SWPPD] was transferred to the Metropolitan Wastewater Department in 2004; and

WHEREAS, the Convention Center Expansion / Dewatering Project [CCE] requires assistance to conduct Convention Center dewatering compliance activities in support of the compliance schedule requested by the San Diego Regional Water Quality Control Board; and

WHEREAS, the Metropolitan Wastewater Department has separate professional services agreements for Engineering, Biological, Environmental, and Construction/Program Management on an as-needed basis, currently funded by the Sewer Revenue Fund; and

WHEREAS, the SWPPD and CCE Funds must be added as authorized funding sources in order for the SWPPD and the CCE to utilize these professional services agreements; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That Storm Water Pollution Prevention Fund No. 100 (General Fund) is hereby added as an authorized funding source to support the requirements of the Storm Water Pollution

Prevention Program for the following agreements managed by the Metropolitan Wastewater Department: Engineering Services 2005-2008; Biological Services 2005-2008; Environmental Services 2003-2006; and Construction/Program Management 2002-2007.

- 2. That the expenditure of funds from Storm Water Pollution Prevention Fund No. 100 is hereby authorized to support the Stormwater Pollution Prevention Program for the above agreements on an as-needed basis, contingent on the City Auditor and Comptroller first furnishing one ore more certificates demonstrating that the funds necessary for expenditure are, or will be, on deposit in the City Treasury.
- 3. That Convention Center Expansion Fund No. 102211 is hereby added as an authorized funding source for the following agreement to support the requirements of the Convention Center Expansion / Dewatering Compliance by the Metropolitan Wastewater Department's Environmental Monitoring & Technical Services: Engineering Services 2005-2008.
- 4. That the expenditure of funds from Convention Center Expansion Fund No. 102211 is hereby authorized to support the Environmental Monitoring & Technical Services' efforts regarding the Convention Center Expansion / Dewatering Project for the Engineering Services 2005-2008 agreement on an as-needed basis, contingent on the City Auditor and Comptroller first furnishing one ore more certificates demonstrating that the funds necessary for expenditure are, or will be, on deposit in the City Treasury.
- 5. That this activity is not subject to the California Environmental Quality Act pursuant to CEQA Guideline section 15378(b)(4), because this activity is a governmental fiscal activity,
