WHEREAS, SHIRLEY PHILLIPS, Associate Director of the San Diego Museum of Man, is retiring after 36 years of dedicated service; and

WHEREAS, SHIRLEY PHILLIPS' contributions to the San Diego Museum of Man in beautiful Balboa Park are significant and long lasting; and

WHEREAS, in 1978, SHIRLEY PHILLIPS, established the first "Christmas on the Prado" and brought together all the museums of Balboa Park to create the first annual "gift to the citizens of San Diego"; and

WHEREAS, SHIRLEY PHILLIPS' dedication to the event has created an annual holiday tradition that has grown each year and has become the beloved "Balboa Park December Nights," which the people of and visitors to San Diego continue to enjoy; and

WHEREAS, in 1984, SHIRLEY PHILLIPS, through her innovation and organizational talents, brought San Diegans the first San Diego Museum of Man "Indian Fair," which has become a continuing annual event hosting numerous Native American artists that showcase their skills in ceramics, painting, sculpture, textiles, jewelry, and carvings, as well as song and dance for the people of and visitors to San Diego; and

WHEREAS, SHIRLEY PHILLIPS, in 1988, became the Museum of Man's special events coordinator and guided the museum's public outreach to the community; and


WHEREAS, during her tenure, SHIRLEY PHILLIPS, served for ten years on the Board of the Museum Store Association, an international organization of museum store professionals whose aim is to better serve their institutions and the public; and

WHEREAS, SHIRLEY PHILLIPS' professionalism, dedication, and contributions to the cultural fabric of the City of San Diego will endure; NOW, THEREFORE,
