DATE OF FINAL PASSAGE MAR 07 2006

WHEREAS, on January 13, 2004, by Resolution Number R-298750, the City Council authorized the award and expenditure of funds for the construction of the Mid-City Transit Gateways Project [Project] Phase 2 funding; and

WHEREAS, the Project has experienced unforeseen site conditions and has a \$100,000 budget deficit to cover contingencies; and

WHEREAS, \$100,000 in additional funding has been requested from the Redevelopment Agency in City Heights Redevelopment Tax Increment funding, and

WHEREAS, this additional funding will make it possible to complete construction; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor be and he is hereby authorized to accept \$100,000 in Redevelopment Tax increment funds for the Mid-City Transit Gateways Project, Phase 2 (El Cajon Blvd. and University Ave. Bridge Decks over Highway 1-15), Capital Improvements Project No 39-232.0, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
2. That the Auditor and Comptroller is authorized to appropriate \$100,000.00 from Fund No. 10259, Redevelopment Contributions to City Heights Projects to CIP No. 39-232.0, Mid-City Transit Gateways Project.

3. That the increase of the FY 06 CIP budget for CIP No. 39-232.0, Mid-City Transit Gateways Project, Fund No. 30244, Dept. No. 30244, Org. No. 106, and J.O. No. 392320, by \$100,000 is hereby authorized.

4. That the expenditure of an amount not to exceed \$100,000 for contingencies is hereby authorized.

BE IT FURTHER RESOLVED, that this project is categorically exempt from CEQA per State CEQA Guidelines Section 15303.
