BE IT RESOLVED, by the Council of the City of San Diego, stating for the record that the Exchange Agreement between the City of San Diego and Simplon Ballpark, LLC, on file with the City Clerk as Document No. RR- **301290** is a subsequent discretionary approval of the Project addressed in the Final Master Environmental Impact Report for the Centre City Redevelopment Project, SCH No. 90010898, and the Final Subsequent Environmental Impact Report for the Centre City Redevelopment Project, as stated in the Final Environmental Secondary Study for the Proposed Cosmopolitan Square Project dated January 2006, on file with the Centre City Development Corporation, and therefore not a separate project under CEQA Guideline sections 15060(c)(3) and 15378(c).

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, stating for the record that the information contained in the Final Master Environmental Impact Report for the Centre City Redevelopment Project, SCH No. 90010898, and the Final Subsequent Environmental Impact Report for the Centre City Redevelopment Project, including any comments received during the public review process, have been previously reviewed and considered by this Council and it is determined that this subsequent discretionary approval of the Exchange Agreement between the City of San Diego and Simplon Ballpark, LLC, on file with the City Clerk as Document No. RR- **301290**, does not involve substantial changes or new information of substantial importance which would warrant any additional environmental review.


