DATE OF FINAL PASSAGE MAR 24 2006

WHEREAS, Sgt. Dale Shockley was hired July 10, 1978, and was promoted to sergeant on February 7, 1990; and

WHEREAS, Sgt. Shockley works in cooperation with other officers and the community to deal with concerns over illegal activity and public nuisances in the San Diego Riverbed; and

WHEREAS, Sgt. Shockley works continuously at Mission Trails Park and developed a procedure to rescue injured or stranded hikers on Cowles Mountain between the San Diego Fire & Rescue Department, San Diego Police Department, and San Diego Park & Recreation Rangers to eliminate any agency conflict; and

WHEREAS, Sgt. Shockley is an active participant on Eastern Division's Homeland Security team to develop police plans and responses for at risk locations and facilities within the Eastern Division's command; and

WHEREAS, Sgt. Shockley organized a response and created operational plans to address problems that might occur during the Lake Murray Fourth of July Street Fair; and

WHEREAS, Sgt. Shockley's hard work has reduced the calls for service in the riverbed area, lessened public health hazards, and is helping restore the riverbed to its natural habitat; and

WHEREAS, Sgt. Shockley's hard work has significantly decreased the homeless/transient problem along the San Diego River; and

WHEREAS, Sgt. Shockley spends countless hours of his personal time addressing community needs and criminal problems to maintain a high level of public safety for the communities of the Navajo Service area; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the citizens of San Diego, does hereby commend Sgt. Dale Shockley for his dedication to making San Diego America's Finest City.

BE IT FURTHER RESOLVED, that March 21, 2006, be and is hereby proclaimed to be "SERGEANT DALE SHOCKLEY DAY" in the City of San Diego.
