WHEREAS, Officer Christina Burhans transferred to the Eastern Division on September 7, 2002, and has taken it upon herself to address a number of issues she discovered in the course of her duties ever since her arrival; and

WHEREAS, Officer Burhans works extensively with elementary school children as an officer on the Juvenile Services Team as well as the Elementary School Safety Program, and she recruits and trains students for the School Safety Patrol program; and

WHEREAS, Officer Burhans, with the help of other officers, surveyed all of the elementary schools in the Eastern Division to identify alternative drop-off locations in order to reduce pedestrian and vehicular traffic problems around the schools in the mornings and afternoons; and

WHEREAS, Officer Burhans has taken a special interest in the 290 sex offender registrants residing in the area, developing a detailed book identifying all of the registrants in the Eastern Division; and

WHEREAS, Officer Burhans regularly updates the officers about sex offenders out of compliance so that they can be located and prosecuted; and

WHEREAS, Officer Burhans attended many community meetings and addressed citizen inquiries regarding various community concerns and criminal issues while she was temporarily assigned to the position of Community Relations Officer for the Serra Mesa Service Area; and

WHEREAS, Officer Burhans voluntarily participated in the School Safety Patrol's Summer Camp where she monitored the children and supervised numerous functions; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the citizens of San Diego, does hereby commend Officer Christina Burhans for her dedication to making San Diego America's Finest City.

BE IT FURTHER RESOLVED, that March 21, 2006, be and is hereby proclaimed to be "OFFICER CHRISTINA BURHANS DAY" in the City of San Diego.
