A RESOLUTION INITIATING AN AMENDMENT TO THE UNIVERSITY COMMUNITY PLAN TO FACILITATE ADDITIONAL FIRE STATIONS IN THE UNIVERSITY COMMUNITY.

WHEREAS, the University Community is served by a fire station located on Eastgate
Mall between Regents Road and Genesee Avenue; and

WHEREAS, the San Diego Fire Department is concerned about poor response times in the University Community and its ability to adequately meet the community needs at this time; and

WHEREAS, the City Council would like to initiate a University Community Plan amendment, which would focus on the need for additional fire stations within the community by adding language to the University Community Plan that identifies such need.

WHEREAS, in accordance with San Diego Municipal Code section 122.0103(a) the City Council may direct the preparation of an amendment to a community plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council directs the Planning Department to prepare an amendment to the University Community Plan that adds language stating the need for additional fire stations to assure adequate response to the population; and

BE IT FURTHER RESOLVED, that this activity will not result in a direct or reasonably foreseeable indirect physical change in the environment and is therefore not subject to CEQA pursuant to State CEQA Guidelines Section 15060(c)(2).
