A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ADOPTING CITY COUNCIL POLICY NO. 700-47 GOVERNING USE OF GAME/EVENT TICKETS FOR THE CITY SUITE AT PETCO PARK AND RELATED PARKING PASSES.

WHEREAS, PETCO Park is a jointly owned facility between the City of San Diego and the San Diego Padres; and

WHEREAS, on February 1, 2000, the Mayor and City Council adopted Resolution No. 292706 outlining the adoption of a Joint Use Management Agreement [JUMA] for the ballpark, enabling the City and Padres to jointly own, operate, maintain and use the facility; and

WHEREAS, Section 2.3 of the JUMA states in relevant part that the City “shall have a right and option to direct the Padres to set aside one (1) Private Suite for use and occupancy by the City throughout the Term;” and

WHEREAS, Section 2.3.3 of the JUMA states in relevant part that the City “as an owner shall be entitled to one admission ticket for each seat in the City Suite for each Event at the Ballpark Property, including Padres Games and Events, free of charge;” and

WHEREAS, Section 2.4 of the JUMA states in relevant part that the City “shall have the right to use and occupy the City Parking free of any obligation to pay parking fees or charges, but the City’s use and occupancy shall be subject to such other reasonable rules and regulations as may be adopted from time to time by the manager of the Ballpark Property;” and

WHEREAS, Section 2.4.1 of the JUMA states in relevant part that the City has “[a] right to use and occupy 15 VIP parking spaces for all Events at the Ballpark Property, at a location to be designated by the Padres;” and

WHEREAS, since PETCO Park’s opening in April 2004 the City of San Diego has exercised its right to use and occupy the City Suite; and

WHEREAS, since April 2004 City staff and City officials have used the JUMA guidelines and existing City Council Policy No. 700-22, which governs use of a similar City-designated area at Qualcomm Stadium, to allocate seats and distribute tickets and parking passes; and

WHEREAS, the City Council desires to establish a new Council Policy No. 700-47 regarding the use of the PETCO Park City Suite, in compliance with JUMA guidelines and regulations of the Fair Political Practices Commission; and

WHEREAS, proposed Council Policy No. 700-47 defines those public officials who are credential holders and specifies in relevant part that credential holders may use tickets for seats in the City suite “for the purpose of promoting or marketing the City of San Diego that may lead to increased economic, governmental or social service benefit to the City;” NOW,

THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that Council Policy No. 700-47, entitled “PETCO Park City Suite,” is approved as set forth in the Council Policy filed in the Office of the City Clerk as Document No. RR-301324 and shall govern use of the PETCO Park City Suite.

BE IT FURTHER RESOLVED, that the City Clerk is instructed to add the aforesaid to the Council Policy Manual.
