WHEREAS, Kimberly Hale is leaving the San Diego Film Commission after serving five years as the Director of Community Relations; and

WHEREAS, during her time with the Film Commission, Kimberly was affectionately known as the "Bull Dog" for her persistence in demanding fairness and cooperation from the community, business, and government that is essential to successful filmmaking; and

WHEREAS, Kimberly's proactive approach to identifying and assessing potential conflicts and communicating with Council Offices resulted in more peaceful and positive experiences for those communities impacted by increasing production in San Diego; and

WHEREAS, in the face of severe budget cuts, Kimberly developed a plan entitled "Upgrade Technology, Downgrade Cost" which saved the Film Commission from losing another staff member. Her plan encouraged the use of e-mail and electronic literature, thus saving the significant cost of paper and postage; and

WHEREAS, Kimberly captured a grant to digitize the location library which enabled photos of City, County, and Port property to be circulated worldwide in seconds. This became a major film, video, and print incentive, luring more businesses to San Diego thereby creating more job opportunities for San Diegans; and

WHEREAS, Kimberly was awarded the "Forty under 40" by Metropolitan Magazine for her unique talents, leadership, and public relations skills; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby declare Tuesday, April 25, 2006, to be "KIMBERLY HALE DAY" in the City of San Diego in honor of her outstanding service and contributions to the people of San Diego.
