A RESOLUTION APPROVING AN AGREEMENT WITH
HIRSCH & COMPANY FOR FY 2006 TELEVISIONING SEWER
MAINS FOR THE METROPOLITAN WASTEWATER
DEPARTMENT


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor is hereby authorized to execute on behalf of the City of San Diego, an agreement with Hirsch & Company for professional services to perform Closed Circuit Televising (CCTV) of sewer pipelines within the City of San Diego for an amount not to exceed \$717,865 [the Agreement].
2. That the expenditure of an amount not to exceed \$717,865 from Fund No. 41506, Department 776, Org. No. 722, Job Order 764030 is authorized for the purpose of funding the Agreement.
3. That the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

4. That this activity is categorically exempt from the California Environmental Quality Act [CEQA] pursuant to State CEQA Guidelines, Section 15306, Information Collection.

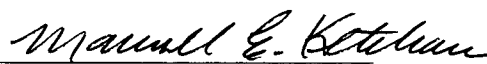
