
WHEREAS, Albatross Drive between West Lewis Street and Front Street is a narrow, two-way residential street

BE IT RESOLVED, by the Council of the City of San Diego, that, pursuant to the authority conferred by and in accordance with the provisions of San Diego Municipal Code section 82.19, the conversion of Albatross Drive between West Lewis and Front Street at the intersection with Montecito Way to an one-way operation westbound, is hereby authorized.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.

BE IT FURTHER RESOLVED, that this action is exempt from the California Environmental Quality Act pursuant to CEQA Guidelines Section 15301 because this action is the minor alteration of an existing facility with a negligible expansion beyond the existing use.
