BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor is authorized and empowered to execute for an amount not to exceed \$51,418 a second amendment to the agreement with T.Y. Lin International, for consulting services on the Rose Creek Bike Path and Pedestrian Bridge Project, under the terms and conditions set forth in the Second Amendment to Agreement on file in the office of the City Clerk as Document No. RR- 301401.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to appropriate and expend an amount not to exceed \$51,418 from CIP 58-147.0, Rose Creek Bike Path and Pedestrian Bridge Project, Fund 30300, TransNet, for the purpose of providing funds for the aforementioned Second Amendment to Agreement, contingent upon the Auditor and Comptroller certifying that the funds are necessary for such expenditure on deposit in the City Treasury.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

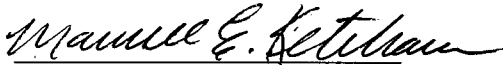
