DATE OF FINAL PASSAGE MAY 10 2006

WHEREAS, on May 9, 1906, 100 years ago, the University Heights Syndicate filed subdivision map No. 985 for the community of Normal Heights with the County of San Diego; and

WHEREAS, Normal Heights has grown and prospered over these last 100 years to become a cohesive neighborhood offering a sense of place for its residents as well as numerous opportunities for community involvement, cultural events and recreational opportunities; and

WHEREAS, one of the earliest of San Diego's many neighborhood business districts, the Carteri Center with its centerpiece, the Carteri Theater, was planned and developed by Bertram J. Carteri and designed by Louis J. Gill in Normal Heights in 1923; and

WHEREAS, the neon Normal Heights sign was designed and erected by Martin Electric as a civic endeavor at the mid-point of the 20th century; and

WHEREAS, the last 25 years have seen the birth and emergence of the Normal Heights Community Association, the Adams Avenue Business Association, the Normal Heights Community Development Corporation, the Normal Heights Community Planning Committee, and the Normal Heights Cultural Council, all current advocates for the betterment of the community of Normal Heights; and

WHEREAS, to this day the City of San Diego and representatives of Normal Heights continue their long-standing partnership, ensuring that Normal Heights continues to be among San Diego's finest neighborhoods; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby congratulate the community of Normal Heights upon the occasion of its centennial celebration.

BE IT FURTHER RESOLVED, that May 9, 2006 be and is hereby proclaimed to be "NORMAL HEIGHTS CENTENNIAL DAY" in the City of San Diego.


