A RESOLUTION CALLING FOR A PUBLIC HEARING TO DETERMINE WHETHER THE PUBLIC HEALTH, SAFETY, OR GENERAL WELFARE REQUIRES THE FORMATION OF UNDERGROUND UTILITY DISTRICTS

WHEREAS, Chapter VI, Article 1, Division 5 of the San Diego Municipal Code establishes a procedure for the creation of underground utility districts and requires as an initial step in such procedure the holding of a public hearing to determine whether the public health, safety, or general welfare requires removal of poles, overhead wires, and associated structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service in any such district; and

WHEREAS, it has been recommended that the following underground utility districts be formed:

- Waring Road/I-8 from Adobe Falls Road to Alvarado Canyon Road, as more fully described in the attachment to this resolution and more particularly shown on Drawing No. 33810-1-D
- La Jolla Mesa Drive from La Jolla Scenic South Drive to Muirlands Drive, as more fully described in the attachment to this resolution and more particularly shown on Drawing No. 33811-1-D
- K Street (Phase 1) from 19<sup>th</sup> Street to 24<sup>th</sup> Street, as more fully described in the attachment to this resolution and more particularly shown on Drawing No. 33817-1-D

 K Street (Phase 2) from 26<sup>th</sup> Street to 30<sup>th</sup> Street, as more fully described in the attachment to this resolution and more particularly shown on Drawing No. 33817-2-D

NOW THEREFORE, BE IT RESOLVED, by the Council of the City of San Diego [City Council], as follows:

- 2. At such hearing, all persons interested shall be given an opportunity to be heard and the hearing may be continued from time to time as may be determined by the City Council. The decision of the City Council as to the formation of the Districts as described above shall be final and conclusive.

The Mayor shall notify all affected persons as defined in Chapter VI, Article 1,
