A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING FUNDS, PLANS AND SPECIFICATIONS; AND PROPERTY ACQUISITION FOR TORREY DEL MAR NEIGHBORHOOD PARK.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the plans and specification for the construction of Torrey Del Mar Neighborhood Park [Project], filed in the office of the City Clerk as Document No. **W.O. 295460**, are approved.
- 2. That, after advertising for bids in accordance with law, the Mayor is authorized to execute a construction contract with the lowest responsible and reliable bidder, and the City Auditor and Comptroller is authorized, upon advice from the administering department, to return excess budgeted funds, if any, to the appropriate reserves.
- 3. That the Fiscal Year 2006 Torrey Highlands Public Facilities Financing Plan, CIP No. 29-546.0 for Torrey Del Mar Neighborhood Park is amended by increasing the appropriation amount by \$1,394,658.
- 4. That the Fiscal Year 2006 Capital Improvements Program Budget for CIP

 No. 29-546.0, Torrey Del Mar Neighborhood Park is amended by increasing the budget amount

 by \$1,394,658 from Fund No. 79015 Torrey Highlands Facilities Benefits Assessment.
- 5. That the appropriation and expenditure of an amount not to exceed \$1,394,658 from CIP No. 29-546.0, Torrey Del Mar Neighborhood Park, Fund No. 79015 Torrey Highlands Facilities Benefit Assessment, is authorized solely and exclusively for the purpose of providing

funds for the Project, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditures are, or will be, on deposit with the City Treasurer.

- 6. That the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$258,784 from CIP No. 29-427.0, Black Mountain Ranch Community Park Acquisition and Development to CIP No. 29-546.0, Torrey Del Mar Neighborhood Park within Fund No. 39069, Torrey Highlands Planned Urbanizing Development Impact Fees.
- 7. That the appropriation and expenditure of an amount not to exceed \$258,784 from CIP No. 29-546.0, Torrey Del Mar Neighborhood Park, Fund No. 39069 Torrey Highlands Planned Urbanizing Development Impact Fees, is authorized solely and exclusively for the purpose of providing funds for the Torrey Del Mar Neighborhood Park, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditures are, or will be, on deposit with the City Treasurer.
- 8. That the acquisition of a 1.4 +/- acre parcel, being a portion of Parcel 2 of Parcel Map No. 147568, as required for the completion of Torrey Del Mark Neighborhood Park, is authorized.
- 9. That the expenditure of an amount not to exceed \$560,000 from CIP

 No. 29-546.0, Torrey Del Mar Neighborhood Park, Fund No. 79015 is authorized for the
 acquisition of property and related closing costs, provided that the City Auditor and Comptroller
 first furnishes one or more certificates certifying that the funds necessary for expenditures are, or
 will be, on deposit with the City Treasurer.
 - 10. That the expenditure of an amount not to exceed \$2,070,558 from CIP
