DATE OF FINAL PASSAGE MAY 11 2006

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN  
DIEGO REGARDING THE FY 2007 COMMUNITY  
DEVELOPMENT BLOCK GRANT PROGRAM.

WHEREAS, the Housing and Community Development Act of 1974 established the Community Development Block Grant [CDBG] Program, which is administered by the U.S. Department of Housing and Urban Development; and

WHEREAS, the purpose of the CDBG Program is to provide an annual source of funds to local governments for the purpose of implementing activities to develop viable urban communities, including decent housing and a suitable living environment and expanding economic opportunities, principally for persons of low and moderate income; and

WHEREAS, the City's CDBG entitlement grant for FY 2007 is \$15,506,862 (which is a \$1,776,120 or 10.3% reduction from FY 2006); and

WHEREAS, on April 25, 2006, Report to the City Council No.06-047 was provided to the City Council, setting forth the complete list of funding allocations and recommendations for the City's FY 2007 CDBG Program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the City Auditor and Comptroller is authorized to accept CDBG funds in the amount of \$15,506,862 from the U.S. Department of Housing and Urban Development for the City's FY 2007 CDBG Program.

2. That the funding allocations and recommendations for the City's FY 2007 CDBG Program, set forth in Report to the City Council No. 06-047, a copy of which is on file with the Office of the City Clerk as Document No. RR- 301424, as modified by memoranda from Council District 2, Council District 4, and Council District 7, a copy of each memorandum is on file with the Office of the City Clerk as Document Nos. RR- 301424-1, RR- 301424-2, and RR- 301424-3, respectively, are approved, contingent upon certification of funds availability by the City Auditor and Comptroller, and that the Core City Priorities and CDBG-Funded Projects approved for funding be incorporated into the City's FY 2007 CDBG Action Plan.

3. That the Mayor or his designee is authorized to negotiate and execute agreements with those CDBG-Funded Projects approved for funding, contingent upon certification of funds availability by the City Auditor and Comptroller.

4. That the Executive Director of the San Diego Housing Commission is authorized to negotiate and execute agreements with those CDBG-Funded Projects approved for funding whose allocations the Mayor or his designee asks the San Diego Housing Commission to administer, contingent upon certification of funds availability by the City Auditor and Comptroller.

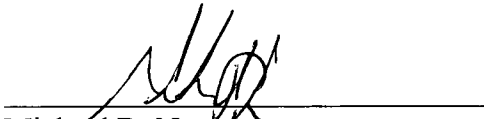
5. That the City Auditor and Comptroller is authorized to appropriate and expend the CDBG funds for the Core City Priorities and CDBG-Funded Projects approved for funding, contingent upon certification of funds availability by the City Auditor and Comptroller.



6. That the the City Auditor and Comptroller is authorized to reprogram funding from prior year CDBG-funded projects to FY 2007 projects approved for funding, contingent upon certification of funds availability by the City Auditor and Comptroller.

7. That the Mayor or his designee is authorized to suspend the initiation of new HUD Section 108 Loans during FY 2007 that rely on CDBG and/or General Funds as a repayment source.

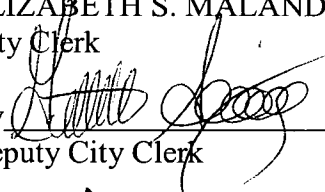
