WHEREAS, in November, 2001, the City filed a Complaint in Eminent Domain against D.R. Horton, San Diego Superior Court Case No. GIC777603-1, to acquire 12.31 acres of a 39.38 acre parcel for the construction of State Route 56; and

WHEREAS, the case came for trial in August 2003, and the jury verdict was \$5,589,200, which was paid; and

WHEREAS, the trial judge granted the property owner's motion for a new trial, which was upheld on appeal. The matter has been set for a retrial on November 17, 2006; and

WHEREAS, in preparation for the retrial, the property owner made a motion in court to increase the deposit of probable compensation to \$16,000,000, which was granted; and

WHEREAS, to comply with the court's order, the City must deposit an additional \$10,410,800 with the State Treasury Condemnation Fund by May 12, 2006; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Fiscal Year 2006 Capital Improvement Program Budget for CIP No. 52-463.0 is amended by increasing the budget amount by \$10,410,800.
- 2. That the appropriation of an amount not to exceed \$10,410,800 from General Fund Unappropriated Reserves, Fund 100, is authorized, solely and exclusively for the purpose of providing funds for the right-of-way acquisitions costs for CIP No. 52-463.0.

- 3. That the issuance of a check in the amount of \$10,410,800, from CIP No. 52-463.0, Fund 100, made payable to the State Treasury Condemnation Fund, is authorized to satisfy a court ordered payment in the State Route 56 eminent domain case, *City of San Diego v. D.R. Horton, et al.*, San Diego Superior Court Case No. GIC777603-1, contingent upon the City Auditor certifying that the funds are available.
- 4. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess budgeted funds, if any, to the appropriate reserves.
