DATE OF FINAL PASSAGE MAY 19 2006

WHEREAS, Duchenne Muscular Dystrophy is a genetic muscle disease that causes the loss of both muscle function and independence, and affects 1 out of 3500 boys worldwide; and

WHEREAS, Duchenne Muscular Dystrophy is usually diagnosed by the age of six, causes boys to stop walking by the time they are nine, and by age eleven they are confined to a wheelchair; and

WHEREAS, Duchenne Muscular Dystrophy eventually affects the muscles of the heart and most of these young men lose their battle with the disorder by the time they reach their late teens; and

WHEREAS, Parent Project Muscular Dystrophy is a national nonprofit organization that is entirely focused on Duchenne Muscular Dystrophy and they are holding their annual Kick for a Cure Charity Soccer Tournament & Festival to benefit children who live with Duchenne Muscular Dystrophy on June 10 & 11, 2006, at Westview High School in San Diego; and

WHEREAS, last year, 104 teams participated in the charity soccer tournament, 3,000 guests attended throughout the weekend, and \$45,000 was donated to Parent Project Muscular Dystrophy; and

WHEREAS, Parent Project Muscular Dystrophy is determined to find a cure for children with this lethal genetic childhood disorder; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby recognize the efforts of Parent Project Muscular Dystrophy to make a difference in the lives of those affected by this disease.

BE IT FURTHER RESOLVED, that June 10, 2006, be and is hereby proclaimed to be **“KICK FOR A CURE FOR DUCHENNE DAY”** in the City of San Diego
