BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Fiscal Year 2006 Capital Improvement Program [CIP] Budget is amended by adding CIP No. 29.906.0, Mission Trails Regional Park Monument Sign.
- 2. That the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$24,430 from Fund No. 10580, Mission Trails Regional Park Antenna Fund, to CIP No. 29.906.0, Mission Trails Regional Park Monument Sign.
- 3. That the City Auditor and Comptroller is authorized to appropriate and expend an amount not to exceed \$24,430 from CIP No. 29.906.0, Mission Trails Regional Park Monument Sign, for the purpose of funding the purchase, shipping, and installation of a new monument sign at Mission Trails Regional Park.

BE IT FURTHER RESOLVED, that this activity is categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15302 (replacement or reconstruction).
