## DATE OF FINAL PASSAGE MAY 1 9 2006

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ACCEPTING GRANT FUNDS FOR SAN DIEGO'S "6 TO 6" PROGRAM AT SIX FAITH-BASED SCHOOLS.

WHEREAS, San Diego's "6 to 6" Program operates at a total of 132 schools in Fiscal Year 2006, which includes six grant funded faith-based schools serving low income communities: Our Lady of the Sacred Heart (CD3); St. Rita's (CD4); Holy Family (CD6); Our Lady of Guadalupe (CD8); Our Lady of Angels (CD8); St. Jude (CD8); and

WHEREAS, the primary funding for these "6 to 6" sites is from \$660,480 in federal 21<sup>st</sup> Century Community Learning Center [21<sup>st</sup> CCLC] grant funds, administered by the State of California Department of Education; and

WHEREAS, in January 2006, staff was notified that the City had been awarded an additional \$295,625 in 21<sup>st</sup> CCLC grant funds to fund "6 to 6" Programs at the six (6) faith-based schools for the period of July 1, 2005 through December 31, 2006, contingent upon the availability of funds per the State Legislature; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the City Auditor and Comptroller is authorized to accept \$295,625 in additional 21<sup>st</sup> CCLC grant funds for the operation of San Diego's "6 to 6" Program at six (6) faith-based schools for the period of July 1, 2005 through December 31, 2006.
- 2. That the Mayor or his designee is authorized to enter into amendments to agreements with existing "6 to 6" providers to expend the grant funds, contingent upon certification of funds availability by the City Auditor and Comptroller.
