DATE OF FINAL PASSAGE MAY 19 2006

RESOLUTION AUTHORIZING TRANSFER AND EXPENDITURE OF FUNDS FOR THE TRAFFIC SIGNAL AND STREET LIGHTING SYSTEM IN THE OTAY MESA-NESTOR COMMUNITY

BE IT RESOLVED, that the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$160,000 from Fund 79517, Otay Mesa-Nestor Development Impact Fee (DIF), to CIP 68-010.0, Traffic Signals-Citywide.


BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to increase the Fiscal Year 2006 Capital Improvement Program budget by \$160,000, Fund 79517, in CIP 68-010.0, Traffic Signals-Citywide.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to appropriate and expend an amount not to exceed \$160,000 from Fund 79517, Otay Mesa-Nestor Development Impact Fee (DIF), CIP 68-010.0, Traffic Signals-Citywide, for the design and construction of a traffic signal and street lighting system at Firethorn Street and Palm Avenue, contingent upon the Auditor and Comptroller certifying that the necessary funds are on deposit in the City Treasury.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess funds, if any, to fund balance, Fund 79517, Otay Mesa-Nestor Development Impact Fee (DIF).

BE IT FURTHER RESOLVED, that this activity is exempt from the California Environmental Quality Act pursuant to CEQA Guidelines section 15303(D).


