WHEREAS, Dr. Patricia Wahl has been the director of the San Diego State University School of Nursing since her arrival at the University in August of 1990 through December of 2005; and is best known for her role in initiating the San Diego State University Nurses Now Program that started in the year 2000; and

WHEREAS, Dr. Wahl, through the Nurses Now Program, has created a partnership between 10 healthcare organizations and San Diego State University; and in doing so has allowed the hiring of more faculty which in turn has allowed an increase from 50 to 90 Nursing Students accepted to the school each semester in the year 2000 and the number will increase to 100 students accepted each semester; and

WHEREAS, Dr. Wahl is active regionally and statewide through the organization of Deans and Directors; and, since arriving at San Diego State University, her participation has been instrumental in opening three new graduate level Nursing Programs: the Nurse Practitioner Program, the Nurse Midwifery Program, and the School Nursing Program; and

WHEREAS, Dr. Wahl has been instrumental in getting human patient simulators for the Nursing students starting in the year 2004, and now San Diego State University has more patient simulators than any other Nursing School in California; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the citizens of San Diego, does hereby proclaim May 10, 2006, to be "PATRICIA WAHL DAY" in the City of San Diego.
