WHEREAS, in 1906, a group of prominent restaurant owners gathered in Los Angeles, California, to form what is now known as the California Restaurant Association [CRA]; and

WHEREAS, CRA is celebrating this year its 100th Anniversary of dedicated service in promoting and protecting the more than 81,000 eating and drinking establishments throughout California, including the 6,800 located within the San Diego region; and

WHEREAS, CRA is the largest and longest serving nonprofit restaurant trade association in the nation, with Chapters located throughout California, including San Diego County - - one of its largest and most influential chapters; and

WHEREAS, the restaurant industry is a vital component of our economy, generating tax revenues for state and local treasuries; and

WHEREAS, the restaurant industry is the largest private employer in California, employing over one million people, including over 95,000 in the San Diego region; and




