WHEREAS, Golden Care Workforce Institute founded the Golden Caregiver Awards as part of its ongoing effort to make sure the people and programs in our community who work to

improve the lives of San Diego County residents are given much deserved recognition; NOW,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and
on behalf of the people of San Diego, does hereby commend Golden Care Workforce Institute
for providing essential educational opportunities to our residents, for filling our community's
need for caregiving professionals, and for creating the Golden Caregiver Awards.
