(Taxable) [Series 2006B Bonds, together with he Series 2006A Bonds, are collectively referred
to herein as Bonds] the proceeds of which will be used to finance new projects within the Project

BE IT RESOLVED by the Council of the City, that the Council hereby approves the issuance of the Bonds as determined by the Agency.
