- 3. That the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$1,250,000 from Fund 41506, C.I.P. No. 46-602.6, Sewer Pump Station 79, to Fund 41506, C.I.P. No. 44-001.0, Annual Allocation, Sewer Main Replacement.
- 4. That the expenditure of an amount not to exceed \$4,779,675 from Sewer Fund 41506, C.I.P. No. 44-001.0, Annual Allocation-Sewer Main Replacement, is authorized solely and exclusively for the purpose of providing funds for the Project and related costs, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

5. That the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
