A RESOLUTION APPROVING PLANS AND SPECIFICATIONS; AWARD OF PUBLIC WORKS CONTRACT; AND TAKING RELATED ACTIONS.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the plans and specifications for the construction of Sewer Group 741 [Project], filed in the office of the City Clerk as Document No. W.O. 177381/187121, are approved.

2. That, after advertising for bids in accordance with law, the Mayor is authorized to award a contract to, and to execute a contract with, the lowest responsible and reliable bidder for the Project, contingent upon the City Auditor and Comptroller first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. That the expenditure of an amount not to exceed \$4,485,180 from Sewer Fund 41506, CIP No. 44-001.0, Annual Allocation – Sewer Main Replacement, is authorized solely and exclusively for the purpose of providing funds for the Project and related costs, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

4. That the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
