A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ACCEPTING DONATIONS PURSUANT TO COUNCIL POLICY 100-102 AND RATIFYING THE COUNCIL ACTION OF APRIL 16, 2006 REGARDING AN ADVERTISEMENT IN THE SAN DIEGO UNION-TRIBUNE.

WHEREAS, on April 16, 2006, a two-page advertisement was published in the *San Diego Union-Tribune* entitled "City of San Diego Citizens' Budget Guide" [Advertisement]; and

WHEREAS, the Advertisement contained a message from the Mayor and a separate message from the San Diego City Council encouraging citizen participation at Council hearings related tot the proposed City budget for the fiscal year 2007; and


WHEREAS, the Advertisement was underwritten by a number of corporations including \$4,000 from Sempra Energy; \$4,000 from QUALCOMM, Inc.; \$4,000 from Westfield Incorporated; \$2,500 from the San Diego County Chapter-California Restaurant Association; \$1,978 from Gen-Probe Incorporated; \$2,500 from the Downtown Residential Marketing Alliance; and \$1,500 from CDC Small Business Finance. The approximate contribution was \$20,478.00; and

WHEREAS, the funding was forwarded to the *San Diego Union-Tribune* to pay for the advertisement; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the accepts the donations received by the City to fund the two-page advertisement that appeared in the *San Diego Union-Tribune* on April 16, 2006, entitled "City of San Diego Citizen's Budget Guide."

BE IT FURTHER RESOLVED, that the Council ratifies their action placing an advertisement on April 16, 2006, in the San Diego Union-Tribune encouraging citizen participation in City Council meetings for the proposed fiscal year 2007 budget.
