DATE OF FINAL PASSAGE JUN 07 2006

AUTHORIZING THE QUITCLAIM OF A CERTAIN WATER
LINE EASEMENT ACQUIRED BY THE CITY OF SAN DIEGO
ON JULY 26, 1971.

WHEREAS, in 1971, the City obtained a 10-foot wide easement for the installation of an 8-inch diameter water line to supply water to the Wild Animal Park; and

WHEREAS, in conjunction with recent construction in the area, New Urban West, Inc., a California corporation, at the request of the Wild Animal Park, relocated the water line to a public right-of-way and replaced the 8-inch line with an upgraded 12-inch line; and

WHEREAS, New Urban West, Inc., has requested that the old easement, which runs across their property, be quitclaimed to them to clear the title to their property; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor is authorized and empowered to execute, for and on behalf of the City of San Diego, a quitclaim
