ADOPTED ON JUN 07 2006

WHEREAS, the City of San Diego was designated its own solid waste Local Enforcement Agency [LEA] by the California Integrated Waste Management Board on November 19, 1997; and

WHEREAS, the LEA is charged with enforcement of State regulations as they relate to solid waste facilities; and

WHEREAS, pursuant to Public Resources Code section 44308, a hearing panel shall be appointed to conduct an appeal hearing in the event that an LEA action is appealed; and

WHEREAS, the chairperson of the governing body may appoint members of the hearing panel; and

WHEREAS, members of the hearing panel shall be selected for their legal, administrative, or technical abilities in areas relating to solid waste management; and

WHEREAS, the hearing panel must include a technical expert in solid waste management and a representative of the public at large; and

WHEREAS, on May 16, 2005, the San Diego City Council confirmed the appointment of Mr. David Ferguson to the LEA Hearing Panel through Resolution No. R-300443; and

WHEREAS, both the docket and the Resolution No. R-300443 indicated a term ending date of January 1, 2006, however, the original "Request for Council Action" contemplated that Mr. David Ferguson serve a two year term ending on January 1, 2007; and


WHEREAS, the Public Resources Code section 44308(a)(5), as amended in 2004, allows appointments by the governing body to the LEA Hearing Panel for four year terms; and

WHEREAS, the San Diego City Council desires to appointed Mr. John Lorman and Mr. Ken Calvert to the Hearing Panel for a four year term to ending on January 1, 2010; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointments by the Council President of the City of San Diego, to serve as members of the Local Enforcement Agency Hearing Panel, for terms ending on the dates indicated below, be and the same is hereby confirmed.


